

NOTICE OF ELECTION
GREENE COUNTY COMMUNITY SCHOOL DISTRICT

Notice is hereby given to the qualified electors of the Greene County Community School District in Greene and Boone Counties, State of Iowa, that a Special School Election will be held on Tuesday, September 10, 2019. The purpose of the election is to replace the Revenue Purpose Statement for money received by the Greene County Community School District from the State of Iowa Secure an Advanced Vision for Education Fund.

“If a majority of eligible electors voting on the question fail to approve this Revenue Purpose Statement, then upon expiration of the current Revenue Purpose Statement, revenues received by the School District from the Secure an Advanced Vision for Education fund shall be expended in the following order:

The payment of bonds for which SAVE Revenue has been pledged;

Reduction of bond levies under Iowa Code Sections 298.18 and 298.18A and all other debt levies;

Reduction of the regular and voter-approved physical plant and equipment levy under Iowa Code Section 298.2;

Reduction of the public educational and recreational levy under Iowa Code Section 300.2;

For any authorized infrastructure purpose of the school district as defined in Iowa Code Section 423F.3(6); and

For the payment of principal and interest on bonds issued under Iowa Code Sections 423E.5 and 423F.4.”

Jefferson Precinct, consisting of voters of the school district within the City of Jefferson plus Bristol, Dawson, Franklin, Grant, Greenbrier, Hardin, Jackson Townships and a portion of Section 12 of Willow Township, Greene County, will vote at GREENE COUNTY COURTHOUSE, SOUTH ROTUNDA, Jefferson, Iowa.

Scranton Precinct, consisting of voters of the school district within the old Scranton Consolidated School District, more specifically described as: City of Scranton and Scranton Township and parts of Kendrick, Jackson and Willow Townships, Greene County, will vote at SCRANTON CITY HALL/COMMUNITY ROOM, Scranton, Iowa.

Grand Junction Precinct, consisting of voters of the school district within the City of Dana, City of Grand Junction, City of Rippey, Dawson, Franklin, Grant, North and South Junction, Paton and Washington Townships, Greene County, and Sections 6 & 7 of Amaqua Township and

Sections 5, 6, 7, & 8 of Union Township Boone County, will vote at ST. BRIGID PARISH CENTER, Grand Junction, Iowa.
